Camp ground regulations and fire instructions

Camping

Like previous years it is during the 2017 Gold Cup possible to camp in relation to the exhibition area from 18 July 2017 at 12:00 until 24 July 2017 at 12:00.

Fire fighting measures

NOTE: The rules for placement of tents, caravans and cars are the same as last year. Among other things, must tents and caravans NOT be situated in the same camping spacings. This means that the tents, eg. grooming tents and tents for housing dogs, should NOT be placed in the same spacings as caravans, auto campers and tent trailers (combi camp). There will be special tent areas marked up on site. In addition, cars must be placed in the dedicated car parking areas. There must NOT be cars parked elsewhere (except for auto campers).

The Fire Authority will conduct fire inspection at the site during the show.

If the camp ground regulations are violated, it may cause tents, caravans etc. that are set up, cannot be approved and tents and caravans must be relocated. Ultimately this could lead to a closure of the site with the proviso that the situation must be rectified before the site can be opened again.

Camp ground regulations

The following fire safety regulations MUST be adopted during the 2017 Gold Cup:

- At the entrance of the site and at the information stand, be acquainted with the fire safety regulations.
- Be acquainted with the camp ground, and the location of fire extinguishers (see map on backside of this paper).
- Dedicated emergency response areas must be kept clear of tents/cars/caravans etc. and other subjects which may increase fire hazards and harden the emergency response capabilities
- Open fire is prohibited
- Caravans and tents MUST NOT be placed in the same squares
- Tents MUST be placed in the dedicated "TENT" squares
- Cars must ONLY be parked on the dedicated car parks and NOT in the tents' and caravans' areas
- Wherever possible, the cars must be parked "front-to-front"
- The following spacing restrictions must be adopted:
 - At least 3 m between caravans, and a maximum of 6 units in each area
 - At least 3 m between tents
- Do not misuse fire extinguishers located on the campground
- Keep the campground clean of combustible rubbish
- Rubbish must be placed in the bins located on the campground

In case of fire:

- Call immediately 112 reporting, fire in caravan/camper or tent at Nyborg Idræts& Fritidscenter, Storebæltsvej 15, Nyborg.
- Evacuate endangered persons to the area next to the camp ground
- Extinguish/limit the fire using available fire extinguishers

In case of an emergency which requires an ambulance:

- Make sure that the injured breathe(s)
- Call immediately 112 reporting, that one or more persons are injured at Nyborg Idræts& Fritidscenter, Storebæltsvej 13, Nyborg, and need an ambulance
- Report your name, and from which phone number you call
- · Stay with the injured until the ambulance arrives

In case of an emergency which requires medical attention (not ambulance)

- In case of instant need of medical attention, call a general practitioner in Nyborg. Phone number may be found in phone book located in the sports arena.
- After 16.00 call the on duty practitioner (vagtlægen). The on duty practitioner will advice you how to act.
